These Terms of Use were last updated on May18, 2018.

These Terms of Use (“Terms of Use”) apply to S&P Global Inc. and its affiliates, which you have a contract with or which provide services to you, (collectively or individually, as applicable, referred to as "**S&P Global**", "**Company**" "**we**", "**our**", "**us**").

By accessing and using any of S&P Global’s websites including any connected mobile application or version thereof (each a "Site"), you agree to be legally bound by these Terms of Use and you represent that you have the legal capacity to be bound by these Terms of Use. The terms "you" and "User" refer to anyone who accesses a Site.
