

Research Update:

Cathay Financial Holding Co. Ltd. Ratings Affirmed At 'twAA/twA-1+'; Outlook Stable

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA' long-term and 'twA-1+' short-term issuer credit ratings on **Cathay Financial Holding Co. Ltd.** (Cathay FHC). The outlook on the long-term rating is stable.

The ratings continue to reflect our view that the consolidated group credit profile is anchored by the group's flagship subsidiary, **Cathay Life Insurance Co. Ltd.** The insurer represents the majority of the group's total assets and shareholders' equity. Cathay Life has a leading market position by most measures, an extensive retail customer base, and solid franchise in Taiwan's life insurance industry.

The ratings also reflect Cathay FHC group's more balanced business diversification than that of other domestic financial groups, and satisfactory investment diversification with strong underlying liquidity. However, these strengths are somewhat offset by the group's average capitalization, albeit a common weakness among Taiwan-based insurer-centric financial holding groups. The ratings on the holding company also reflect its subordination to the group's core entities.
