MSIG Mingtai Insurance Co. Ltd. Ratings Affirmed At 'twAAA'; Outlook Stable

May 28, 2025

Rationale

Taiwan Ratings Corp. today affirmed its 'twAAA' long-term financial strength rating and issuer credit rating on **MSIG Mingtai Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings on MSIG Mingtai Insurance reflect our assessment of the company's very strong capital and earnings. It also reflects the insurer's satisfactory brand and reputation, which benefit from a good local market position and franchise and brand association with its Japan-based parent group. In addition, the ratings benefit from likely strong group support, given our view of MSIG Mingtai Insurance as a highly strategic entity to the parent group.

Several factors temper these strengths, including the insurer's business concentration in Taiwan's non-life sector with limited geographic diversification and small capital base relative to international peers However, these are common attributes of Taiwan-based non-life insurers.
