Research Update:

Hua Nan Financial Holdings Co. Ltd. Ratings Affirmed At 'twAA-/twA-1+; Outlook Stable

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA-' long-term and 'twA-1+' short-term issuer credit ratings on Hua Nan Financial Holdings Co. Ltd. (Hua Nan FHC).

Our assessment of the Hua Nan FHC group reflects the stand-alone credit profile of **Hua Nan** Commercial Bank Ltd., which dominates the group's credit profile and accounts for over 90% of the group's consolidated financials. In our view, Hua Nan Bank has strong, albeit declining capitalization, with good domestic presence supported by established franchise, and a satisfactory funding and liquidity profile. Counterbalancing factors include competitive pressure on the bank and the FHC group's profitability, and the group's relatively concentrated revenue stream compared with global peers, given its main revenue contribution comes from Hua Nan Bank.

The ratings on Hua Nan FHC reflect a notch of subordination to its core operating entities or the consolidated group credit profile. In our opinion, potential government support for Hua Nan Bank is unlikely to extend to other group entities, including Hua Nan FHC. The notching is also sensitive to changes in the group's double leverage ratio to prevent too deviation from the industry average.
