# O-Bank Number One REIT 'twBBB+/twA-2' Ratings Affirmed; Outlook Stable

June 9, 2025

## **Rating Action Rationale**

Taiwan Ratings Corp. today affirmed its 'twBBB+' long-term and 'twA-2' short-term issuer credit ratings on **O-Bank Number One Real Estate Investment Trust** (O-Bank No.1 REIT). The outlook on the long-term rating is stable.

The ratings continue to reflect our assessment that the O-Bank No. 1 REIT's limited asset base, modest asset quality, and significant concentration in both properties and tenants will remain key constraints over the next one to two years. However, the trust's conservative debt leverage policy, with a maximum leverage of 25% of liability to assets ratio, partially counterbalance its credit weaknesses.
