

Research Update:

Shinshin Credit Corp. Ratings Affirmed At 'twA/twA-1'; Outlook Stable

June 25, 2025

Rating Action

Taiwan Ratings Corp. today affirmed its 'twA' long-term and 'twA-1' short-term issuer credit ratings on **Shinshin Credit Corp.** The outlook on the long-term rating remains stable. The ratings on Shinshin Credit reflect our view of potential support from the company's immediate parent, **Yulon Finance Corp.**, if needed, given the company's core status to the parent.

In addition, the ratings reflect our view of Shinshin Credit's strong capitalization good market position in commercial vehicle financing, and increasingly diversified business mix including corporate finance and energy development. However, Shinshin Credit's moderate risk control framework compared with local banks somewhat tempers these strengths.
