

Research Update:

Standard Chartered Bank (Taiwan) Ltd. Ratings Affirmed At 'twAA+/twA-1+'; Outlook Stable

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA+' long-term and 'twA-1+' short-term issuer credit ratings on **Standard Chartered Bank (Taiwan) Ltd.** (Standard Chartered Taiwan). The outlook on the long-term rating is stable.

The ratings on Standard Chartered Taiwan reflect the bank's highly strategic status to its parent group, Standard Chartered Bank (Hong Kong) Ltd. We anticipate Standard Chartered Taiwan would receive necessary support from the group under almost all foreseeable circumstances. In addition, the ratings reflect the bank's strong capitalization and strong liquidity with diversified funding sources. Counterbalancing these strengths are Standard Chartered Taiwan's moderate earnings capacity in the highly competitive domestic market and less-diversified business compared to international peers.
