### **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twAAAf' fixed-income fund credit quality rating on **Invesco Taiwan Money Market Fund**. The rating affirmation reflects the very strong credit quality of the fund's portfolio exposure compared with global peers', as well as the fund house's strong management and organization, risk management and compliance, credit culture and credit research capability. These strengths are tempered by the industry risks faced by Taiwan-based fixed-income funds.
