# Fubon No.1 REIT Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

October 24, 2019

## **Rating Action Rationale**

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on **Fubon Number One Real Estate Investment Trust** (Fubon No.1 REIT). The outlook on the long-term rating is stable. The ratings on Fubon No.1 REIT continue to reflect the trust's satisfactory asset quality and stable cash flow generation. The trust's relatively small asset portfolio and higher concentration risk in comparison with those of global peers temper these strengths.
