# Shinkong Insurance Co. Ltd. Ratings Affirmed At 'twAA+'; Outlook Stable

November 26, 2019

Taiwan Ratings Corp. today affirmed its 'twAA+' long-term issuer credit rating and financial strength rating on **Shinkong Insurance Co. Ltd.** The rating outlook is stable. The ratings on Shinkong Insurance reflect our view of the insurer's strong competitive position supported by its good control over its distribution channels in Taiwan, as well as its satisfactory operating performance. The ratings also reflect Shinkong Insurance's very strong capital and earnings and adequate investment risk profiles. These provide a good buffer against business downturns and capital market volatility. Despite being the third largest property and casualty insurer in Taiwan, the insurer's smaller scale and less geographic business diversification than its international peers somewhat offsets these strengths.
