Taiwan Cooperative Bank Ltd. Ratings Affirmed At 'twAA+/twA-1+'; Outlook Stable

March 23, 2020

Rationale

Taiwan Ratings Corp. today affirmed its 'twAA+' long-term and 'twA-1+' short-term issuer credit ratings on **Taiwan Cooperative Bank Ltd.,** as well as our issue credit ratings on the bank's various senior and unsecured subordinated debts (see Ratings List). The outlook on the long-term rating is stable.

The ratings on Taiwan Cooperative Bank reflect the bank's good market position and established franchise in Taiwan's banking industry, as well as strong capitalization and satisfactory funding and liquidity profile. Counterbalancing factors include the bank's mediocre profitability relative to similar-rated global peers. The ratings also reflect the 'bbb' anchor for banks in Taiwan and our view of implicit support for Taiwan Cooperative Bank from the Taiwan government, given to the bank's high systemic importance in the domestic banking system.
