### **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twA' long-term and 'twA-1' short-term issuer credit ratings on **Capital Securities Co. Ltd.** We then withdrew the ratings at the company's request. The outlook on the long-term rating prior to withdrawal was stable.
