# Carplus Auto Leasing Corp. Ratings Affirmed At 'twA-/twA-2'; Outlook Stable

June 18, 2020

## **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twA-' long-term and 'twA-2' short-term issuer credit ratings on **Carplus Auto Leasing Corp.** The outlook on the long-term rating is stable. The ratings on Carplus mainly reflect our view of the company as a core subsidiary of the Yulon Finance Corp. group, as well as Carplus' strong business position in the domestic auto leasing market and the company's adequate capital. The ratings also reflect our view that Carplus has adequate risk controls with better loss experience compared with its domestic peers', despite unfavorable market conditions amid COVID-19 have temporarily weakened the company's overall asset quality.

We believe that as a core subsidiary of Yulon Finance, Carplus will receive necessary support from its parent and the ratings on Carplus will move in tandem with our assessment of Yulon Finance's credit profile.
