Bank SinoPac Ratings Affirmed At 'twAA-/twA-1+'; Stable Outlook

August 19, 2020

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA-' long-term and 'twA-1+' short-term issuer credit ratings on Bank SinoPac. The outlook on the long-term rating is stable. At the same time, we affirmed the issue ratings on the bank's subordinated debentures (see ratings list).

The ratings on Bank SinoPac reflect the bank's strong capitalization relative to its risk profile, as well as the bank's adequate funding and liquidity profile. Counterbalancing these strengths are the bank's moderate profitability by global standards and scale disadvantage relative to that of its international peers.
