# BankTaiwan Life Insurance Co. Ltd. Ratings Affirmed At 'twAAA'; Outlook Stable

# **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twAAA' long-term insurer financial strength and issuer credit ratings on Taiwan-domiciled **BankTaiwan Life Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings on BankTaiwan Life reflect the likelihood that the insurer will remain a core subsidiary of the Taiwan Financial Holding Co. Ltd. group along with the group's banking arm, **Bank of Taiwan**. We classify Bank of Taiwan as a government-related entity and we believe there is an extremely high likelihood that the government of Taiwan would provide timely, sufficient, and extraordinary support to the bank, as needed. We believe this support will extend through the holding company and shared by BankTaiwan Life whenever needed.
