Yu Rich Financial Services Co. Ltd. Ratings Affirmed At 'twA-/twA-2'; Outlook Stable

Rating Action

Taiwan Ratings Corp. today affirmed its 'twA-' long-term and 'twA-2' short-term issuer credit ratings on Yu Rich Financial Services Co. Ltd. The outlook on the long-term rating is stable. The ratings on Yu Rich Finance reflect our view of potential support from its parent, Yulon Finance Corp., if needed, given Yu Rich Finance carries core strategic importance role in the parent group's business strategies. We also view Yu Rich Finance has strong capitalization relative to its risk profile. The company's business scale disadvantage and less comprehensive risk framework than those of local banks temper these strengths.
