# Hua Nan Financial Holdings Co. Ltd. And Hua Nan Commercial Bank Ltd. Ratings Affirmed; Outlook Stable

May 14, 2021

# **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twAA-' long-term and 'twA-1+' short-term issuer credit ratings on **Hua Nan Financial Holdings Co. Ltd.** along with the 'twAA+' long-term and 'twA-1+' short-term issuer credit ratings on **Hua Nan Commercial Bank Ltd.** The outlook on long-term ratings is stable. At the same time, we affirmed the issue credit ratings on the bank's various unsecured subordinated debts (see Ratings List).

The ratings reflect our assessment of Hua Nan Financial Holdings group's strong capitalization, good domestic market positions supported by an established banking franchise, as well as satisfactory funding and liquidity profile. Counterbalancing factors include the group's weaker profitability and relatively concentrated revenue stream compared with global peers'. The ratings on Hua Nan Commercial Bank also reflect our view of implicit government support for the bank given its moderate systemic importance in Taiwan's banking system.
