Taian Insurance Co. Ltd. Ratings Affirmed At 'twAA'; Outlook Stable

Rating Action

On June 17, 2021, Taiwan Ratings Corp. affirmed its 'twAA' long-term insurer financial strength and issuer credit ratings on Taiwan-domiciled **Taian Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings reflect Taian Insurance's very strong capital and earnings that provides a good buffer to absorb losses, along with the insurer's good liquidity and cash flow, and satisfactory investment risk profile. Taian Insurance's relatively smaller scale and less geographic business diversification compared with those of regional peers somewhat offsets these strengths.
