Shinshin Credit Corp. Ratings Affirmed At 'twA-/twA-2'; Outlook Stable

June 28, 2021

Rating Action

Taiwan Ratings Corp. today affirmed its 'twA-' long-term and 'twA-2' short-term issuer credit ratings on Shinshin Credit Corp. The outlook on the long-term rating is stable. The ratings on Shinshin Credit reflect our view of potential financial support from the company's immediate parent, Yulon Finance Corp., if needed, due to Shinshin's core status within the parent group. We also view Shinshin Credit as having a good market position in commercial vehicle financing. The company's less comprehensive risk framework than local banks' tempers these strengths.
