Standard Chartered Bank (Taiwan) Ltd. Ratings Affirmed At 'twAA+/twA-1+'; Outlook Stable

Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA+' long-term and 'twA-1+' short-term issuer credit ratings on **Standard Chartered Bank (Taiwan) Ltd.** (Standard Chartered Taiwan). The outlook on the long-term rating is stable.

The ratings on Standard Chartered Taiwan reflect the bank's highly strategic status to its parent, Standard Chartered Bank (Hong Kong) Ltd. We anticipate that Standard Chartered Taiwan would receive necessary support from the Standard Chartered Bank group under almost all foreseeable circumstances. The ratings on Standard Chartered Taiwan also reflect the bank's strong capitalization following its efforts to optimize its balance sheet, and the bank's strong liquidity with diversified funding sources. Partly offsetting these strengths are the bank's moderate earnings capacity in the highly competitive domestic market and less-diversified business versus that of its international peers.
