# 'twAAA/twA-1+'Ratings On Taiwan High Speed Rail Corp. Affirmed; Outlook Stable

## **Rationale Action Rationale**

Taiwan Ratings Corp. today affirmed its 'twAAA' long-term and 'twA-1+' short-term issuer credit ratings on **Taiwan High Speed Rail Corp.** (THSRC). The outlook on the long-term rating is stable. The ratings on THSRC reflect the company's leading market share in commercial and long-distance trips in Taiwan, above-average profitability compared to that of its peers, and its strong operating cash flow generation despite the temporary setback during the COVID-19 pandemic. The ratings also reflect our view of a very high likelihood of timely and sufficient extraordinary support from the government of Taiwan, if needed. THSRC's high debt leverage partly offsets these strengths.
