# Taishin D.A. Finance Co. Ltd. Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

October 28, 2021

## **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on Taishin D.A. Finance Co. Ltd. The outlook on the long-term rating is stable. The ratings on Taishin D.A. Finance reflect our view of potential support from the parent, if needed, due to the company's strategically important role in the group's business strategies. We also believe Taishin D.A. Finance will maintain very strong capitalization in coming two years with supportive capital policy and higher earnings retention. The company's business scale disadvantage and less comprehensive risk framework than those of local banks tempers these strengths.
