# Taishin Financial Holding Co. Ltd. And Taishin International Bank Co. Ltd. Ratings Affirmed; Outlook Stable

# **Rating Action**

Taiwan Ratings Corp. today affirmed its long-term and short-term issuer credit ratings on **Taishin Financial Holding Co. Ltd.** (Taishin FHC) and **Taishin International Bank Co. Ltd.** (Taishin Bank), as well as our issue credit rating on the bank's financial debentures (see Ratings List). The outlook on the long-term ratings is stable.

The ratings on Taishin Bank and Taishin FHC continue to reflect our assessment of the group's satisfactory market position in Taiwan's consumer banking business, adequate revenue diversification with a stable fee-income base, as well as the bank's strong capitalization relative to its risk profile. The group's moderate profitability by international standards and smaller business scale compared with similarly rated international peers temper these strengths. The ratings on Taishin FHC also reflect its non-operating holding structure and subordination to the group's core entity, Taishin Bank.
