Research Update:

Shinkong Insurance Co. Ltd. Ratings Affirmed At 'twAA+'; Outlook Stable

November 19, 2021

Rationale

Taiwan Ratings Corp. today affirmed its 'twAA+' long-term insurer financial strength and issuer credit ratings on Taiwan-domiciled **Shinkong Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings on Shinkong Insurance reflect our view of the insurer's strong competitive position as indicated by its favorable underwriting performance and well-controlled distribution channel. The ratings also reflect Shinkong Insurance's very strong capital and earnings and adequate investment allocation profile. These provide a good buffer against business downturns and capital market volatility. Despite being the third largest property and casualty insurer in Taiwan, the insurer's smaller scale and less geographic business diversification than its international peers somewhat offset these strengths.
