# Societe Generale, Taipei Branch Ratings Affirmed At 'twAA+/twA-1+' Under Revised Criteria; Outlook Stable

February 16, 2022

### **Overview**

- We reviewed our ratings on SG Taipei under our revised criteria.
- We affirmed the 'twAA+/twA-1+' issuer credit ratings on the bank. The stable outlook remains unchanged.

# **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twAA+' long-term and 'twA-1+' short-term issuer credit ratings on **Societe Generale, Taipei Branch (SG Taipei)**. The outlook on the long-term rating remains stable. The affirmation follows a revision to our methodology for rating financial institutions (see "Financial Institutions Rating Methodology," published Dec. 9, 2021).

### Rationale

Our ratings on SG Taipei reflect our view that the Taipei branch has the same creditworthiness as its parent. We believe Paris-based Societe Generale will fulfill the Taipei branch's financial obligations on a timely basis, if needed.

# Outlook

The stable rating outlook on SG Taipei reflects the outlook on the parent. The ratings on SG Taipei will move in tandem with those on its parent.
