Taiwan-based Yageo Corp. Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

February 25, 2022

Rating Action Overview

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on **Yageo Corp.** The outlook on the long-term rating is stable.

The ratings on Yageo reflect the company's good market positions in various passive components, Yageo's comprehensive product offering that secures stable client relationships, and the company's above average profitability compared with its peer. The ratings also reflect our view that Yageo's enhanced EBITDA generation along with likely moderate capital expenditure and debt-funded merger and acquisitions are likely to help the company keep its ratio of debt to EBITDA at 1.5x-2.0x over the next one to two years. Standardized products and limited technology barriers that lead to intense competition and volatile pricing, as well as highly cyclical demand particularly from IT-related applications somewhat offset these strengths.
