Aerospace Industrial Development Corp. Ratings Affirmed At 'twAA/twA-1+'; Outlook Remains Negative

May 16, 2022

Rating Action Rationale

Taiwan Ratings Corp. today affirmed its 'twAA' long-term and 'twA-1+' short-term issuer credit ratings on **Aerospace Industrial Development Corp.** (AIDC). The outlook on the long-term rating remains negative, which reflects the downside risk that the company's ratio of debt to EBITDA could remain above 5x for a prolonged period.

The ratings on AIDC reflect the company's monopoly role providing self-developed aircraft to Taiwan's military with sustainable business from the maintenance of such aircraft, the government's policy to increase self-sufficiency in airborne defense, as well as relatively stable of commercial aircraft's engine business. In addition, we believe there is a very high likelihood the company will receive extraordinary government support should AIDC experience financial stress. These strengths are partly offset by the company's relatively small scale and limited projects on hand, high client concentration with strong bargaining power, and high debt leverage.
