# FCB Leasing Co. Ltd. Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

# **Rating Action**

Taiwan Ratings Corp. affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on **FCB Leasing Co. Ltd.** The outlook on the long-term rating is stable. The ratings on FCB Leasing reflect our view of potential support for the leasing company from its financially stronger parent First Financial Holding Co. Ltd. group, based on FCB Leasing's strategically important status of the group. The ratings also reflect the company's very strong capitalization and adequate funding and liquidity supported by the parent group's resources. Counterbalancing factors include FCB Leasing's limited operating scale in Taiwan's finance and leasing industry and moderate risk position due to some single-name concentration and volatilities.
