Union Insurance Co. Ltd. Ratings Affirmed At 'twAA'; Outlook Stable

September 16, 2022

Rationale

Taiwan Ratings Corp. today affirmed its 'twAA' long-term insurer financial strength and issuer credit ratings on Taiwan-domiciled **Union Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings on Union Insurance reflect our view of the insurer's very strong capital and earnings over the next one to two years, sufficient liquidity and cash flow, and diversified asset allocation of investment portfolios. The ratings also reflect Union Insurance's stable market position, steady operating performance, and medium level of controlled distribution channels. Counterbalancing these strengths are the insurer's relatively small scale and its small capital base in the domestic market.
