## Research Update:

# Taipei Fubon Commercial Bank Co. Ltd. Ratings Affirmed At 'twAA+/twA-1+'; Outlook Stable

October 26, 2022

# **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twAA+' long-term and 'twA-1+' short-term issuer credit ratings on **Taipei Fubon Commercial Bank Co. Ltd.** (Taipei Fubon Bank). The outlook on the long-term rating is stable. At the same time, we affirmed the issue ratings on the bank's various unsecured subordinated debentures (see ratings list).

The ratings on Taipei Fubon Bank reflect our view that the Taiwan government would provide financial support to the bank, if needed, given the bank's moderate systemic importance in the domestic banking industry. The ratings also reflect the bank's strong capitalization and adequate risk controls with satisfactory asset quality. Counterbalancing these strengths are the bank's moderate profitability by international standards and less-diversified business stream than that of its international peers.
