# Taishin D.A. Finance Co. Ltd. Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

## **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on **Taishin D.A. Finance Co. Ltd.** The outlook on the long-term rating is stable, which reflects the outlook on the ultimate parent, **Taishin Financial Holding Co. Ltd.** The ratings on Taishin D.A. Finance reflect our view of potential support from the parent group, if needed, due to the company's strategically important role in the group's business strategies. We also believe Taishin D.A. Finance will maintain very strong capitalization over the next two years with a supportive capital policy. The company's business scale disadvantage and less comprehensive risk frameworkthan those of local banks temper these strengths.
