# **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twAA' long-term insurer financial strength and issuer credit ratings on **The First Insurance Co. Ltd.** The outlook on the ratings is stable. The ratings on First Insurance reflect the insurer's very strong capital and earnings, adequate investment risk profile, as well as exceptional liquidity. The company's moderate business scale in Taiwan's competitive non-life insurance market and less geographic business diversification compared with those of regional peers somewhat temper these strengths.
