Millerful No.1 Real Estate Investment Trust Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

December 19, 2022

Rating Action Rationale

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on **Millerful No.1 Real Estate Investment Trust** (Millerful No.1 REIT). The outlook on the long-term rating is stable. The ratings on Millerful No.1 reflect the trust's satisfactory asset quality and diversification. Although rental income from Taimall property has rebounded significantly in 2022 along with the diminishing adverse impact of the pandemic, the trust's relatively small asset portfolio in a global context and potential volatility associated with rental collection from the trust's Taimall property and dividend income from overseas REITs continue to temper these strengths.
