Research Update:

Ratings Affirmed On Taiwan Cooperative Financial Holding Co. Ltd. And Taiwan **Cooperative Bank Ltd.; Outlooks Stable**

January 16, 2023

Rating Action

Taiwan Ratings Corp. today affirmed its long-term and short-term issuer credit ratings on **Taiwan** Cooperative Financial Holding Co. Ltd. and Taiwan Cooperative Bank Ltd., as well as our issue credit ratings on the bank's unsecured subordinated debts (see Ratings List). The outlook on the long-term ratings is stable.

The ratings reflect our assessment of the group's good market position and established franchise in Taiwan's banking sector, the bank's strong capitalization, as well as strong funding and adequate liquidity profile. Counterbalancing factors include the group's mediocre profitability relative to similar-rated global peers. The ratings on the bank also reflect our view of a high likelihood of support from the Taiwan government in times of need, given the bank's high systemic importance in the domestic banking system. In addition, the ratings on the holding company reflect its relative subordination to its major operating subsidiaries.
