Research Update:

Ratings On Vanguard International Semiconductor Corp. Affirmed At 'twA+/twA-1'; Outlook Stable

April 27, 2023

Rating Action Rationale

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on **Vanguard International Semiconductor Corp.** The outlook on the long-term rating is stable. The ratings and outlook on Vanguard reflect our view that the company's sufficient financial buffer with high cash on hand and slowing down capacity expansion plan could help the company to sustain its net cash position in 2023-2024, despite low utilization amid a market downturn. We also expect Vanguard to defend its pricing during the current period of demand weakness, given the company's improving product mix and client relationship management.

In addition, the ratings continue to reflect Vanguard's good position and competitive technology capability in providing mature foundry services. However, the rating strengths are tempered by the company's product and client concentration with smaller operating scale as well as weaker pricing power and absolute profitability than global leading peers. In addition, technology transition will bring some downside risks to Vanguard's stable performance over the longer-term.
