Taiwan Life's Upcoming Series 112-1A Ten-Year Unsecured Subordinated Corporate Bond Rated 'twAA-'

June 26, 2023

Rating Action

Taiwan Ratings Corp. today assigned its 'twAA-' issue rating to Taiwan Life Insurance Co. Ltd.'s proposed Series 112-1A ten-year unsecured subordinated corporate bond..

Rationale

The rating on the Series 112-1A ten-year unsecured subordinated corporate bond is one notch lower than the long-term issuer credit rating on Taiwan Life (twAA/Stable/--) based on our financial services sector issue rating criteria (see Related Criteria). The notching reflects the bond's subordinated status. The Series 112-1A bond ranks senior to Taiwan Life's ordinary shares and junior to the company's senior liabilities, with respect to the payment of interest and relevant amounts upon liquidation.

The main purpose of the issuance is to enhance Taiwan Life's regulatory capital adequacy ratio. Any material change in the proposed terms could affect the rating.
