Rating Action

Taiwan Ratings Corp. today affirmed its 'twAA' long-term and 'twA-1+' short-term issuer credit ratings on **Shinkong Number One Real Estate Investment Trust** (Shinkong No.1 REIT). We then withdrew the ratings at the trust's request. The outlook at the time of withdrawal was stable. The trust has liquidated all its real estate assets and is scheduled to distribute the liquidation proceeds to investors on December 15, 2023.
