# Taiwan Cooperative Securities Co. Ltd. Ratings Affirmed At 'twAA-/twA-1+'; Outlook Stable

January 29, 2024

## **Rating Action**

Taiwan Ratings Corp. today affirmed its 'twAA-' long-term and 'twA-1+' short-term issuer credit ratings on **Taiwan Cooperative Securities Co. Ltd.** The outlook on the long-term rating is stable. The ratings on Taiwan Cooperative Securities reflect our view of a high likelihood of support from its parent, **Taiwan Cooperative Financial Holding Co. Ltd.** group, if needed. We base this on our view that the company holds highly strategic group status. The ratings on the securities firm also reflect its strong capitalization. Taiwan Cooperative Securities' relatively small operating scale in the local securities industry and moderate risk control on its investment somewhat offset these credit strengths.
