# CTCI Corp. Ratings Affirmed At 'twA/twA-1'; Outlook Stable

March 26, 2024

## **Rating Action Overview**

Taiwan Ratings Corp. today affirmed its 'twA' long-term and 'twA-1' short-term issuer credit ratings on **CTCI Corp.** The outlook on the long-term rating is stable. The ratings on CTCI reflect the company's sustained domestic market leadership, expanding overseas operating scale, and improving business diversity that will underpin its competitive position over the next one to two years. In addition, the ratings reflect our base case that CTCI's ratio of debt to EBITDA will increase substantially to about 2x over the next two to three years, given its significant capital expenditure (capex) and working capital needs.

CTCI's smaller operating scale compared with that of its large-scale global engineering, procurement and construction (EPC) peers, weaker profit margin in its overseas EPC business, and high volatility of the company's leverage for capex and working capital swings somewhat temper these strengths.
