Research Update:

Next Commercial Bank Co. Ltd. Ratings Affirmed At 'twA+/twA-1'; Outlook Stable

Rating Action

Taiwan Ratings Corp. today affirmed its 'twA+' long-term and 'twA-1' short-term issuer credit ratings on **Next Commercial Bank Co. Ltd.** (Next Bank). The outlook on the long-term rating is stable.

The ratings on Next Bank reflect the bank's strong capitalization relative to its risk profile, adequate liquidity backed by sizeable highly liquid assets, as well as potential technical support from **Chunghwa Telecom Co. Ltd.** and **Mega International Bank Co. Ltd.** The ratings also reflect our view of a very high likelihood that the largest shareholder, Chunghwa Telecom would support Next Bank, given our assessment of the bank's strategic importance to the Chunghwa Telecom group. These strengths are tempered by Next Bank's small, albeit improving, market presence and developing deposit franchise in Taiwan's highly competitive banking sector, as well as the bank's unseasoned risk exposure during high expansion.
