# Zyxel Group Corp. Ratings Affirmed At 'twA-/twA-2'; Outlook Stable

April 9, 2024

# **Rating Action Rationale**

Taiwan Ratings Corp. today affirmed its 'twA-' long-term and 'twA-2' short-term issuer credit ratings on **Zyxel Group Corp.** The outlook on the long-term rating is stable.

The ratings on Zyxel reflect the company's satisfactory technology capability, improving competitive environment, and early entry in the fifth generation (5G) home gateway market. Zyxel's moderate profitability should enable the company to generate discretionary cash flow and maintain a net cash position over the next one to two years. This is despite the company's likely weak operating performance in 2024. Several factors partly offset these strengths, including Zyxel's small operating scale, weak brand name, low bargaining power against major clients, and weak and volatile profitability which will continue to constrain the company's business profile.


