Rating Action

Taiwan Ratings Corp. today affirmed its 'twBBB+' long-term and 'twA-2' short-term issuer credit ratings on **Kings Town Bank International Lease Corp.** The ratings reflect our view that the company is a strategically important member of its parent group, which is led by Kings Town Bank, and would receive support from its financially stronger parent in times of financial distress.

In addition, the ratings on the leasing company reflect adequate capitalization and adequate funding and liquidity supported by the bank's resources. Counterbalancing factors include the company's limited operating scale in Taiwan's finance and leasing industry and moderate risk position due to some single-name concentration and higher exposure to Taiwan's real estate markets.
